TO CONSIDER FILLING OF SENIOR TECHNICAL NON TEACHING GROUP 'A' LEVEL POSTS IN THE INSTITUTE.

### Minutes of the last meeting It was resolved that though the institute intends to achieve the ultimate target of faculty and non-faculty posts to the ratio of 1:1.1, yet it is not in the interest of the institute to either keep or abolish certain essential posts without which the affairs of the institute cannot be managed. Such posts can also not be out-sourced. It was, therefore, decided that the institute may again request the Ministry to allow the institute to fill up the following essential posts within its sanctioned strength by relaxing the stipulated ratio of 1:1.1 as stated above.

#### Action taken

The Govt. of India, MHRD vide their letter no.F.No.7-2/2009 TS dated 11.05.2009 has conveyed approval for revival and filling up of all the five Sr. Technical non teaching posts. The institute has already initiated the process to fill up these posts. However, recruitment process is held up for the time being due to vacancy of Chairman, BOGs.

Notes: 1. The Chairman of the Selection Committee may co-opt an additional expert, if considered necessary.

- 2. As regards senior technical non teaching posts, the selection committee as applicable in the case of Lecturer will be applicable.
- 3. At least five members including the Chairman and experts must constitute the quorum.
- 4. For selection of Professor post, preferably a senior most Professor will be associated.

This constitution is based on the guidelines issued by the AICTE vide their letter No.F.No.1-65/CD/NEC/98-99 dated July 31, 2001 for teaching posts.

The Selection Committee for Career Advancement of faculty is also the same as that for direct recruitment as per AICTE guidelines. Accordingly, the Selection Committee for promotions of institute faculty under Career Advancement is also the same. As the Chairman of the Selection Committee is either the Chairman, Board of Governors of the institute or his nominee, therefore, because the position of Chairman, Board of Governors is lying vacant since 23.2.2009, the institute could not held any meeting of the Selection Committee. Consequently the recruitment as well as promotions of faculty are lying held up. In order to prevail over this situation, it is proposed that in the absence of Chairman, Board of Governors or his nominee, the Selection Committee meetings may be chaired by the Joint Secretary / Additional Secretary, MHRD, Incharge Technical Bureau or the Director of the Institute so that the recruitment / promotional process does not held up under the aforesaid circumstances.

The eligibility criteria for allotment of residence of certain type is based on the designation and pay scale in case of faculty and on the basis of pay drawn in case of non faculty employees. The eligibility criteria for allotment of residence of certain type to the non faculty employees the institute has been following the criteria determined by the Government of India, Directorate of Estates for the general pool government residences in Delhi.

Due to revision of pay structure on the recommendations of Sixth Central Pay Commission, the Government of India, Directorate of Estates vide their notification No.F.No.12035/1/98-Policy II dated 03.02.2009 have amended allotment of Government residences (General Pool in Delhi), Rules, 1963, a copy of which is attached as **Annexure VIII** at page Nos. 135 to 137. Since the institute has also revised the pay structure of the institute employees (non-faculty) on the basis of recommendations of Sixth Central Pay Commission, it is therefore, proposed that the above said rules may be adopted for determining the eligibility of institute employees (non faculty) for allotment of residence of certain type as under:
