TO CONSIDER THE ACTION TAKEN BY THE INSTITUTE REGARDING THE POST- GRADUATE PROGRAMMES.

The Board of Governors in their 95th meeting held on 16 June, 2003 recommended that the institute, jointly with other sister institutes, pursue with Ministry of Human Resource Development (MHRD) regarding continued offering of ME Programmes. Accordingly all the NITTTRs were constantly following up the matter with MHRD at various fora from time to time. Subsequently the institute also submitted a proposal to MHRD to offer "Credential-Oriented Modular Training Programme for Technical Teachers" leading to ME degree in November, 2003.

Additional Secretary, MHRD in a recent meeting on September 01, 2004 with all the four institutes, reviewed the matter alongwith other activities relating to training etc. and gave his, in principle approval, to:

- Continue offering post-graduate programmes.
- Make concerted efforts for obtaining "Deemed University Status" to institute.
- Prepare a Vision Document that reflects the institute as an emerging Centre of Excellence.

The institute has already initiated action on the above directions of MHRD.

Finance Committee may recommend to the Board to accord approval to the institute actions to :

- Offering Post-Graduate Programmes;
- Making efforts for Deemed University Status; and
- Preparing the Vision Document.
