Dr. Prabhjot Kaur, Incharge, Punjab Technical University (PTU), Mohali Campus, Mohali vide her letter dated 05.02.2013, Regional Director, National Cooperative Development Corporation (Regional Office), SCO No.82-83, 2nd Floor, Sector 17-C, Chandigarh vide their letter No.NCDC:RO(N)/27-33/86/309 dated 19.08.2013 and Shri D.B.Negi, Senior Regional Director, Indira Gandhi National Open University, SCO 208, Sector-14, Panchkula (Haryana) vide his letter No.IG/RCC/Staff Welfare/13/522 dated 09.04.2013, has also requested for allotment of houses for its employees.

Keeping in view the vacancy of the houses, since long, and their day to day maintenance, institute considered the above said requests and allotted the following houses:

Type IV (A): 1 (One) 1309-C, Sector 42-B, Chandigarh.

Type-III (A): 5 (Five) 1318-C,1319-C,1320-C, 1321-A and 1321-C, Sector 42-B, Chandigarh

Type-I: 11 (Seven) 67-A, 67-B, 68-A, 68-B, 69-A, 69-B, 70-B, 71-A, 71-B, 72-A, 72-B, Sector 29-A, Chandigarh

The above said houses have been allotted to the above organisations as per the agreement between Institute and organisations. The broad terms and conditions are as under:

- The organisations shall pay to the institute, the licence fee and house rent allowance admissible to each allottee.
- The institute shall have the right to get the house(s) vacated by giving three months notice in writing. The organisations will also have the right to surrender the allotted house by giving three months notice or rent in lieu of notice period in writing.
- Any unauthorized occupation, wholly or partially, shall invite damage charges @ 100 times of the normal licence fee.
- The organisations shall furnish an irrevocable bank guarantee of Rs.1,00,000/- in favour of Director, NITTTR, Chandigarh. The institute shall have the right to encash the bank guarantee to recover unpaid dues/damages etc.
- Routine maintenance of allotted houses will be taken up by the Institute by following the proper procedure.
- In case of any natural disaster/epidemic, the concerned department shall fully
 cooperate with the Institute. The institute shall not be responsible for any loss to
 concerned department or its employees occupying the institute accommodation due
 to any natural calamity/ disaster.

- Neither concerned department nor its allottee(s) shall carry out any commercial activities in the allotted houses.
- Concerned department shall be responsible for any damage not arising out of normal wear and tear. The institute shall have the right to recover any such damages.
- In case of any kind of damages to the institute accommodation by the allottee deliberately, the damage charges shall be collected by the concerned department from the allottee and deposited with the NITTTR, Chandigarh.

TO CONSIDER THE REQUEST OF DR. HEMANT SOOD FOR PAY FIXATION CONSEQUENT UPON HIS PROMOTION AS PROFESSOR UNDER CAREER ADVANCEMENT SCHEME

The Board of Governors in its 28th meeting (vide item No. B 28.2 against item No. B 23.3.10) held on 01.10.2013 had approved granting of in situ promotion to Dr. Hemant Sood from Associate Professor to Professor under Career Advancement Scheme in the pay band of Rs.37400-67000 with AGP of Rs.10,000/-.

In compliance of the decision of the Board of Governors, Dr. Hemant Sood was promoted as Professor under Career Advancement Scheme vide office order No. 167 dated 31.10.2013 in the pay band of Rs.37400-67000 with AGP of Rs.10,000/-.

Now Dr. Hemant Sood vide his letter 12.11.2013 has requested that his pay may be fixed as per institute rules.

It is worth mentioning here that the promotion of Dr. Sood was done as per AICTE guidelines dated 31.7.2001. As per Govt. of India letter dated 19 September, 2002 (copy enclosed), financial benefit and designation are to be given to the incumbent from date on which the selection committee meeting takes place. The selection committee in the case of Dr. Hemant Sood met on 13.5.2010.

In the light of above, the Board of Governors may kindly decide whether benefit is to be given from the date of selection committee meeting i.e. 13.5.2010 or from the date of issue of promotion orders i.e. 31.10.2013 so that necessary option may be asked from Dr. Sood for pay fixation.

ITEM NO.B.30.5.5 TO CONSIDER CLEARANCE OF DUES OF LATE DR. DD SHARMA, PROFESSOR EDIC DEPARTMENT

Dr. DD Sharma who was working as Professor at this institute unfortunately expired on 2.7.2013. As per the office records Dr. DD Sharma had made a nomination in the name of his late wife Prof (Mrs) Rekha Råni and in case of her death (50% equal share) in the name of his two sons namely Mr. Bhuvan Sharma and Suraj to whom the right has been conferred to receive any gratuity that may be sanctioned by the Institute in the event of his death while in service. Similar nomination had been made for releasing benefits under the employees group saving linked

insurance scheme by late Dr. DD Sharma. Copies of nominations made by Dr. DD Sharma are enclosed as Annexure - IX & X at page Nos.21 to 22. The wife of late Dr. DD Sharma had expired on 6.10.2005

After the death of Dr. DD Sharma this office has received a letter from Mrs Vidyotama Sharma from Nagrota Bhagwan, Distt. Kangra HP stating that she is wife of late Dr. DD Sharma and has requested for making payment of all the dues to her. She has attached marriage certificate issued by Sub Division Magistrate Cum Marriage Officer, Baijnath Kangra HP. She has also requested for compassionate appointment. A copy of the same alongwith Marriage certificate is enclosed as Annexure – XI at page Nos.23 to 24. The institute has also received a legal notice from Mr. Arvind Mehta, Advocate, Vill. Khalta PO Sanghol, Teh. Jaisinghpur, Distt. Kangra(HP) under instructions and on behalf of Smt. Vidyotama Sharma stating that all sort of amount/funds etc payable after the death of Dr. DD Sharma may be released to her to avoid any unnecessary complications. A copy of legal notice is also enclosed as Annexure - XII at page Nos.25 to 26.

Another legal notice (copy enclosed as Annexure –XIII at page No. 27) from Anshul Kaushal, Advocate on the letter pad of Anil Kumar Kaushal, Advocate has been received under the instructions and authorization of his client Mr. Bhuvan Sharma and Mr. Suraj, sons of late Dr. DD Sharma stating that some persons with vested interest are trying to claim the service benefits and service records in an illegal manner on the basis of forged and fabricated documents. He has requested not to give any information to any person other than the legal heirs of deceased. It may be mentioned that as per service rules relating to gratuity, leave encashment, insurance claim, benefits under New Pension Scheme etc. the nominees of the deceased employee are entitled to the dues payable in the event of death of an employee.

Shri Arvind Mehta, Advocate Palampur (HP) vide his time bound legal notice dated 2.9.2013 has again submitted that his client Smt. Viddyotama Sharma resident of vill. And PO Mahakall, Teh. Baijnath, Distt. Kangra (HP) is the legally wedded wife of Dr. Druv Dev Sharma son of Shri Keshav Ram Sharma. He has further stated that on account of ill health of his client, she is unable to visit this office and as such all the necessary papers relating to family pension and other service benefits on account of death of the husband of his client in harness, be sent to his client for signature and for fulfilling other formalities necessary for the purpose and any sort of amount/funds etc. be released to his client as is admissible according to share and entitlement to avoid unnecessary complications in the matter at later stage. He has requested that reply be sent within 15 days from the receipt of this letter.

In this regard the institute vide letter No.NITTTR/Admn/E-1/16729 dated 12.8.2013 had requested the Institute Counsel to give his opinion on who, out of the two parties is entitled for the following:

- (i) Gratuity
- (ii) Leave encashment
- (iii) Benefits under the employees group saving insurance scheme
- (iv) Benefits under New Pension scheme
- (v) Job on compassionate ground, if available
- (vi) Procedures/documents required for sanctioning their claims; and
- (vii) to intimate this institute whether the authenticity of the marriage certificate sent by Mrs Vidyotama Sharma is required.

The Institute counsel vide his letter dated 19.11.2013 has given his opinion as under:

- (i) The amount of gratuity payable on the death of Dr. DD Sharma has to be paid to his sons as per the nominations
- (ii) The amount of employees group savings linked Insurance Scheme has also been nominated by late Dr. DD Sharma to paid to his sons in the event of his wife predeceasing him. The amount on this account is also to be paid to his sons.
- (iii) The amount of leave salary as per FRSR Part-III Leave Rules, is liable to be paid to his surviving widow in accordance with the Rule 39-C of the Leave Rules, 1972.
- (iv) As regards the retrial benefits under the New Pension Scheme, the nominees who are two sons of the deceased Dr. DD Sharma would be entitled to receive such benefits as also claim appointment on compassionate grounds, if eligible.
- The procedure required for dealing such cases in the routine/normal matter may be followed as per rules;
- (vi) Since photocopy of marriage certificate has been supplied, the applicant may be asked to produce original for perusal and processing of the case.

It is stated that Dr. DD Sharma had opted to shift from Contributory Provident Fund (CPF) Scheme to was New Pension Scheme which was introduced by Government of India from Jan 1,2004. Accordingly, his retirement benefits are to be finalized and paid by PFRDA/NSDL. Pension papers would be processed by this institute and sent to PFRDA/NSDL for regulating pensionary benefits after the issues discussed above are resolved. The CPF amount upto December 2003 of late Dr. DD Sharma is lying with the institute and as per the directions of Govt.of India, MHRD issued vide its letter No.7-24-2011 dated 01.01.2013, the entire corpus under CPF is to be transferred to the "Trust Fund under NPS". Since Late Dr. DD Sharma alongwith other employees have filed a writ petition in the Hon'ble High Court of Punjab and Haryana, praying that their CPF contributions upto December 2003 may not be transferred to the "Trust Fund under NPS", the Institute vide letter dated 2.8.2013 has requested Govt. of India to give the directions whether we should transfer the entire corpus to the "Trust Fund under NPS" as per the directions of MHRD or should wait the decision of Hon'ble High Court of Punjab and

Haryana. The reply from the Ministry is still awaited. The next date of hearing the case 15.07.2014.

Regarding the amount of employees group saving linked insurance scheme, as per the legal advice of the institute counsel, it is proposed that the matter may be taken up with the LIC for making payment to the sons of deceased Dr. DD Sharma.

As regards, leave encashment, it is to be paid to the surviving widow of deceased Dr. DD Sharma. However, it is for the information of the Board of Governors that prior to the death of Dr DD Sharma, neither Dr. DD Sharma intimated the institute about his marriage with Vidyotama Sharma nor Mrs Vidyotama Sharma intimated the institute about her marriage with late Dr. DD Sharma.

- Dr. JS Saini who is presently looking after Rural Development Department, the Govt. of India Scheme of Mainstreaming Persons with Disabilities in Technical and Vocational Project, Project of skill development and other projects involving liaisioning with government agencies like, MHRD, AICTE, NPIU, other organizations and Industry was placed as Dean Extension Services and Consultancy
- Dr.PK Tulsi, Professor, Education and Educational Management who is highly involved in promotion of Research & Development (policy and planning Research, Systemic Research, Applied Research etc) for the benefit of technical education in the country, was placed as Dean Research & Development

Dr. JS Saini, Dean Extension Services and Consultancy has requested that Deans in the institute may be paid an honorarium as they are performing additional duties. In support of his request he has enclosed a letter from NITTTR, Bhopal (copy enclosed as **Annexure – XIV** at page No.28) where an honorarium of Rs.3000/- per month is being paid for performing additional duties.

In the light of above, the Board of Governors may kindly consider and decide payment of honorarium of Rs.3000/- per month to the Deans as per the pattern of NITTTR Bhopal.

A meeting of the committee was held on 16.08.2013 at 11.30 a.m. in the Board Room of the institute under the chairmanship of Dr. BS Pabla for considering the case of re-designation of Section Officers in the Grade Pay of Rs.4200 and Rs.4600 at this institute.

History of the case

On the recommendations of Sixth Pay Commission, the following pay scales were merged in the grade pay of Rs.4200:-

- i) Pre-revised pay scale 5000-150-8000 = Revised pay scale 9300-34800 + GP 4200
- ii) Pre-revised pay scale 5500-175-9000 = Revised pay scale 9300-34880 + GP 4200
- iii) Pre-revised pay scale 6500-200-10500 = Revised pay scale 9300-34800 + GP 4200

Consequent upon merger of various pay scales as per recommendations of the Sixth Central Pay Commission the post of Superintendent was re-designated as Section Officer by the internal Committee constituted by the Director vide Office Order No. 232 dated 17.03.2009 with the approval of Board of Governors in its 13th meeting held on 13.2.2009 vide item No. 13.4.1.

Later on, Govt. of India, Ministry of Finance, Department of Expenditure, Implementation Cell vide letter F.No.1/1/2008-IC dated 13.11.2009 has extended Grade Pay of Rs.4600/- to pre-revised scale of Rs.6500-10500.

At present this institute is having one post of Section Officer in the Pay Band of Rs.9300-34800 with Grade Pay of Rs.4600/- and 05 posts of Section Officers in the Pay Band of Rs.9300-34800 with Grade Pay of Rs.4200/-.

It is also added here that Govt. of India, Ministry of Education and Culture (Department of Education) vide letter No.F.7-14/82-T.1 dated 9.11.1982 has upgraded post of Administrative Officer to Senior Administrative Officer. Presently there is no sanctioned post of Administrative Officer as per staff structure of this institute.

Mr.R.K. Malik is senior most Section Officer and is working in the Grade Pay of Rs.4600/-.

To differentiate between Section Officers having GP Rs.4600/- and those with GP Rs. 4200/-, the committee which met on 16.08.2013 has recommended as follows:

- The post which carries the Grade Pay of Rs.4600/- be re-designated as Section Officer (Grade-I)
- 2. The post which carries the Grade Pay of Rs.4200/- be remain as Section Officer

The following faculty members were granted in situ promotion under the Career Advancement Scheme of AICTE as Assistant Professor in the pre-revised pay scale of Rs.12000-420-18300 from the date mentioned against each.

As per AICTE guideless "Lecturers Master degree and completed 5 years at the level of Lecturer (Sr. Scale), those do not have Ph.D degree, they are required to obtain Ph.D degree within a period of seven years from the date of his/her promotion to the post of Assistant Professor. Copy of AICTE guidelines are enclosed as Annexure - XV at page Nos.29 to 32.

As per the above rules the above faculty members were promoted subject to the condition that they will complete their Ph.D within a period of seven years. A copy of office order vide which both these faculty members were promoted is enclosed as **Annexure - XVI** at page Nos.33 to 34.

Both these faculty members were asked to inform the status of their Ph.D to the office at the earliest vide institute letter NoI NITTTR/Admn/E-1/727-28 dated 19.11.2013. A copy of the same is enclosed as **Annexure - XVII** at page No.35.

In response the above letter, the above faculty members have informed that the condition of completing PhD for designating them as Assistant Professor from Lecturer (Selection Grade) under CAS was imposed with reference to office order No. 191 dated 7.12,2006, wherea's with the implementation of 6th pay commission of Government of India at the institute wef 1.1.2006 they were designated as Associate Professor based on their designation and pay scale as on 01.01.2006. Therefore, the condition of doing PhD is no more applicable in their case. Copies of their replies are enclosed as **Annexure - XVIII** at page Nos. 36 to 37.

6th pay commission and AICTE guidelines provides that incumbent Assistant Professor and incumbent lecturers selection grade who have completed 3 years in the pre-revised scale of Rs.12000-18300 on 1.,1.2006 shall be placed in Pay Band of Rs.37400-67000 with AGP of Rs.9000 and shall be re-designated as Associate Professor.

Shri Gupta was granted selection grade on 28.4.2003 and promotion as Assistant Professor (in situ) on 2.12.2006. He had completed 3 years in the pre revised scale of Rs.12000-18300 on 28.4.2006. He was placed in Pay Band of Rs.37400-67000 with AGP of Rs.9000 was re-designated as Associate Professor wef 28.4.2006

Similarly Mrs. Rama Chhabra was granted selection grade on 22.3.2004 and Assistant Professor on 22.3.2007. She had completed 3 years in the pre revised scale of Rs.12000-18300 on 22.3.2007. She was placed in Pay Band of Rs.37400-67000 with AGP of Rs.9000 was redesignated as Associate Professor wef 22.3.2007

The pay band of Rs.37400-67000 with GP of Rs.9000 and designation of Associate Professor was given only on account of their promotion as Assistant Professor under career advancement scheme wef.2.12.2006 and no where it has been mentioned in the 6th pay commission / New AICTE guidelines that the clause which was imposed as per old AICTE guidelines has been withdrawn in new AICTE guidelines / 6th pay commission.

Since the period of 7 years from the date of promotion as Assistant Professor in respect of these faculty members has since elapsed but these faculty members are yet to obtain their Ph.D degrees.

In view of the above, the Board of Governors may kindly see and advise the action to be initiated.

THE BOARD OF GOVERNORS MAY KINDLY SEE AND ADVISE THE ACTION TO BE INITIATED IN SUCH CASES

TO INFORM ABOUT THE STATUS OF Ph.D IN RESPECT OF MRS POONAM SYAL AND DR. MRS LINI MATHEW, ASSOCIATE PROFESSOR

The Institute in 20th meeting ((vide item No. B 20.3.2) held on 25.6.2011 had informed the Board of Governors of this institute that two faculty members namely Mrs Lini Mathew, Associate Professor (earlier Assistant Professor) and Mrs. Poonam Syal, Associate Professor(Earlier Assistant Professor) who were having Master's Degree in appropriate Branch of Engineering/Technology with 5 years of experience in teaching/industry/research at the level of Lecturer were appointed as Assistant Professor in February 2004 within the condition that they have to obtain Ph.D Degree within a period of seven years from the date of appointment as Assistant Professor(Now Associate Professor) as per the condition laid down in AICTE guidelines dated 19.02.2003 for the appointment to the post of Assistant Professor.

It was informed that Mrs.Poonam Syal and Mrs Lini Mathew did not complete their Ph.D within the prescribed limit of 7 years from the date of their appointments as Assistant Professor and asked for extension beyond the prescribed period of seven years to complete their Ph.Ds. As there are no prescribed guidelines from AICTE / MHRD if an individual does not obtain PhD degree within the prescribed limit of 7 years, the members of the Board of Governors had advised that separate cases for the extension may kindly be placed before the Board. It was also decided that as the faculty members have not fulfilled the prescribed condition, their next increment may be stopped.

In compliance of the decision of the Board of Governors the increments of both the faculty members were stopped from 2012 onwards and an item regarding extension in the period beyond 7 years for completing Ph. D was placed in 21st meeting (item No..B.21.3.4) of the Board of Governors. The Board of Governors was of the opinion that before giving any extension, factual reasons for not completing Ph.D within the stipulated time of seven years may be ascertained. In addition opinion of guide regarding the status of Ph.D and the expected date of completion be sought. Simultaneously the case may be pursued with AICTE regarding clarification on the issue.

The institute vide letter dated 8.12.2011 asked the above faculty members the reasons for not completing Ph.D within the stipulated time of seven years. The opinion of the guide regarding the status of PhD was also obtained. Simultaneously, the Institute had also requested AICTE to intimate the action to be initiated in such cases vide letter No. NITTTR/Admn/E-1/28603 dated 19.12.2011.

The status of above cases consisting of reasons for not completing Ph.D within stipulated time, opinion of guide was placed before the Board of Governors in their 23rd meeting held on 13.3.2012.

"Member Secretary informed the house that Mrs Lini Mathew has submitted her Ph.D thesis with Panjab University on 14.2.2012. After going though the request of Mrs. Poonam Syal and the opinion of the guide regarding the present status of her Ph.D, the Board of Governors decided that being an exceptional case, one more year extension may be given to Mrs Poonam Syal for submission of her Ph.D thesis. No further application for extension will be entertained in future.

In compliance of the above decision of Board of Governors, the office vide letter dated 19.4.2012 had conveyed Mrs Poonam Syal that the Board of Governors has granted one more year extension i.e. upto 23,.2.2013 for submission of her Ph.D. She was informed that no further extension will be entertained in future.

The action taken by the institute as per the directions of the Board of Governors was informed to Board of Governors in its 25th meeting held on 23.6.2012.

Mrs Lini Mathew vide her letter dated 12.2.2013 again informed that she has passed the examination for the award of degree of Doctor of Philosphy(Ph.D) vide result notification No. DOC/2013/1 of the syndicate session dated 27.1.2013 and requested the institute to release her increment.

The status of Ph.D in respect of Mrs Lini Mathew was placed in 27th meeting of the Board of Governors. It was also informed that the increment of Mrs Lini Mathew has been released wef 4.2.2013 i.e. from the date of award of Ph.D degree.

As regards Mrs Poonam Syal, it was informed to the Board of Governors vide her letter dated 11.3.2013 had requested for grant of extension for a period further period of six months to submit her Ph.D thesis.

The Board of Governors of Governors had directed as under:

(1) Issue show casuse notice to Mrs Poonam Syal, Associate Professor, for not completing Ph.D within the prescribed time limit, indicating why she should not be reverted back to the post of Lecturer(no Assistant Professor)

(2) The case for promotion to next higher position under Career Advancement scheme of Mrs Poonam Syal be considered only after three years period from the date of completion of her Ph.D In compliance of the decision of the Board of Governors in its 27th meeting (vide item No. B 27.5.5) held on 26.4.2013, show cause notice was issued to Mrs Poonam Syal vide No. NITTTR/Admn/E-1/373 dated 3.7.2013. As per notice, she was requested to explain her position as to why she has not completed her Ph.D within the prescribed time limit and even after one year extension within 10 days from issue of this notice.

Mrs Poonam Syal vide her letter dated 24.7.2013 had submitted her reply and the same was placed before the Board of Governors in its 28th meeting (item No.B.28.4.6) held on 1.10.2013. As the PhD degree of Mrs Poonam Syal was not yet awarded, the Board of Governors decided to take the decision on the issue only after the award of Ph.D degree to Mrs. Poonam Syal. The Board of Governors also directed that the issue be again brought to the next Board of Governors meeting.

Mrs Poonam Syal vide her letter dated 6.3.2014 has informed that she has completed her Ph.D under faculty of Engineering & Technology from Punjab University wef 5,3.2014. A copy of letter alongwith PhD degree is enclosed.

Now Mrs Lini Mathew, Associate Professor vide her letter dated 8.5.2014 has requested that her candidature for promotion as Professor under Career Advancement Scheme may be considered as she has completed her Ph.D and other requirement necessary for the same. She has also submitted the PBAS proforma for considering her Promotion under Career Advancement Scheme.

Keeping the above fact in view, the Board of Governors may kindly advise further course of action on the issue.
