### TO CONSIDER ENHANCEMENT OF ALLOWANCE PAYABLE TO THE PART TIME HOSTEL WARDEN OF THE INSTITUTE

The Committee recommended that the institute may have one Faculty Member as a Senior Hostel Warden and two Assistant Hostel Wardens i.e. one for Boys wing and second for Ladies wing. Senior Hostel Warden may be paid Rs. 1,500/- per month and Assistant Hostel Wardens be paid Rs.1,000/- per month each without charging license fee for their accommodation in the campus.

# ITEM No. F.20.2.3 TO CONSIDER PROMOTION OF LDC UNDER 10% QUOTA FROM MSA WHO ARE IN THE GRADE PAY OF Rs.1800/-

The Committee was of the opinion that a competitive examination/test, as earlier approved by the Finance Committee/Board of Governors may be kept. However, there should be no age bar for internal candidates for this purpose as approved by the Board of Governors in March, 1989.
