## ITEM NO.B.55.5.5 TO REPORT OF THE MEETING OF THE COMMITTEE TO LOOK INTO HARASSMENT AGAINST WOMEN

A complaint of harassment from Dr Poonam Syal, Professor and Head, Rural Development Department against Dr U.N Roy, Professor Rural Development Department was received by the Committee to look into Harassment against Women. The institute committee consisting of twelve members, including outside expert (Advocate) looked into the matter.

The meeting of the committee was convened on 26.3.2021 in which Dr Poonam Syal was called to appear before the committee However, Another meeting was convened on for oral statement. 15.4.2021 in which Dr UN Rov was asked to give the reply in to the complaint filed by Dr Poonam Syal on or his defence before 15.04.2021. Dr UN Roy was asked to appear before the committee which was held on 19.4.2021. The committee convened another meeting on 16.8.2021 in presence of both the The committee decided in the meeting that one more opportunity of hearing should be given for fair justice of both the parties for which another meeting was convened on 9.9.2021. Both the parties were given an opportunity to sit separately to strike an amicable solution. But in spite of best efforts by the committee ,the parties could not reach to any amicable solution and continued accusing each other. The committee after discussions and deliberations on all the issues and the documents presented by both the parties and the averments made in the complaint minuted their observations. **Annexure – XIX (Pg.No.36).** The committee is of the view that mental agony has been inflicted upon Dr Poonam Syal due to rude behavior of Dr UN Roy.

The committee is of the view that it is up to the competent authority of the institute to decide as per the letter submitted by Dr Poonam Syal on 9.9.2021 (copy enclosed) as Annexure – XX (Pg.No.37) to take appropriate action against Dr UN Roy for his behavior and causing metal agony to Dr Poonam Syal.

Apropos of the Board of Governors approval to item No. B 22.2 in the BOGs meeting held on 24.12.2011, for sponsoring regular faculty members for presenting papers in international conferences/ symposium/convention/workshop/seminar, the paper of concerned faculty member is to be evaluated by the Standing Committee, which is duly appointed by the Director consisting of (i) Director of the institute as Chairman; (ii) Two Professors of the institute to be nominated by the Director, out of which one must be related to the subject of the paper. And (iii) A prominent academician/technocrat from an outside reputed institution/organization with dealing technical education considered relevant to the field of work covered in the paper, after the recommendations Faculty Development Programme of the Committee.

It has been observed that once the paper is accepted by the host organization and recommended for presentation by the FDP Committee as per the laid down criteria, there is really not much need for Standing Committee to evaluate the paper. The institute will save the finances being spent on the travel and honorarium etc. for the

external expert, if the procedure of Standing Committee (which doesn't serve much purpose) is discontinued. However, the procedure and criteria approved by BOGs its 42<sup>nd</sup> meeting held on 24.9.2018 vide Item No. 42.4.6 and 44<sup>th</sup> meeting held on 29.3.2019 vide Item No. 44.2 (copies enclosed) **as Annexure – XXI (Pg.No.38-42)** will be followed by the Faculty Development Programme Committee to recommend such cases.

## ITEM NO. COUNTING OF PAST SERVICE AND CAS PROMOTION OF B. 55.6.1 DR. K.C. LACHHWANI

The case of Dr. KC Lachhwani, Assistant Professor, Applied Science Department for Counting of past service and CAS promotion was puup to the Board of Governors in its 52<sup>nd</sup> meeting vide Item No.B. 52.4. held on 23.12.2020. The Board resolved as under:

"The Board after detailed deliberations approved to count the past services of Dr. KC Lachhwani, hence, the institute has to screen him for stage 2 to 3 w.e.f. 19.3.2015. However, the institute was advised to verify that his initial appointment at Government Engineering College, Bikaner through public advertisement and open selection. The consideration of past services is subject to withdrawal of court case by Dr. KC Lachhwani and satisfying the condition that his initial selection was through a regular selection through public advertisement and having selection committee and followed procedures as per government norms."

Accordingly, institute requested Principal, Government Engineerin College, Bikaner vide letter No. 2300, dated 8.2.2021 and subsequer reminder was sent to Principal , GEC Bikaner vide No. 58, date 8.4.2021 for the required details of initial appointment of Dr. Ki Lachhwani at GEC, Bikaner. Principal, GEC, Bikaner vide their lette No. 538, dated 9.4.2021 informed that the initial appointment of Dr. Ki Lachhwani on the post of Lecturer (Mathematics) was through (i) Ope Selection; (ii) through Public Advertisement (Advt.No. Ecb/Estt/2004/11 and (iii) through section committee duly approved by State Governmer /Executive council of Engineering College, Bikaner Society as lai down by AICTE. Further, this is to inform that the post of Dr. Lachhwar was filled with the prescribed selection procedure as per AICTE, GC norms in consultation of State Government rules.

Further, the BOG in its 53rd meeting vide Item No. 53.2 held o 23.3.2021 has noted the Item No. B 52.4.7.

Dr. KC Lachhwani vide his letter dated 29.4.2021 has requested t clear his case at earliest positively with the statement as under:

"At this stage, I undertake that I shall immediately withdraw court case when I get CAS promotion letter from institute."

In order to reduce the litigation & Court fee to be paid to the Council c the Institute, it is proposed that Board of Governors may kindl reconsider its above decision (Item B.52.4.7) and approve to count th past services of Dr. KC Lachhwani to screen him for CAS promotio from stage 2 to 3 wef 19.3.2015, without pressing upon him th condition to withdraw the court case, as he has already given a undertaking that he will immediately withdraw court case, when he get CAS promotion letter from the institute.
