- c) The demand draft along with prescribed copy of the objection form should be sent by Speed Post to The Director, National Institute of Technical Teachers Training & Research, Chandigarh, Sector-26, Chandigarh 160 019 on or before <u>06th June 2022 by 4:00 PM</u>.
- d) In case the objection(s) sought is upheld, the money would be refunded in total after the recruitment process is completed.
- e) No request for objection(s) of provisional answer keys beyond the last date as stipulated will be entertained.
- f) Objection(s) without Demand Draft and relevant reference will not be processed.
