

ITEM NO. B.50.0: WELCOMING THE CHAIRMAN AND THE MEMBERS

Shri Jagdish Rai Singal, Hon'ble Ex-Chairman, BOGs, SLIET, Longowal, was holding the additional charge of Chairman, BOGs, NITTTR Chandigarh, has tendered his resignation with a request to the MHRD, GOI to get relieved w.e.f 30.6.2020. This led to a defacto resignation from the additional charge of Chairman, BOG of NITTTR, Chandigarh.

Apropos of the clause 12(g) of MOA, with the consent of the esteemed Members, Shri Madhu Ranjan Kumar, Joint Secretary (DL, BP & A), MHRD, GOI, was requested to chair the 50th meeting of the Board of Governors.

ITEM NO. B. 50.5.4 TO CONSIDER AND APPROVE TO FILL-UP THE MOST PRIORITY NON-TEACHING POSTS-THROUGH OPEN ADVERTISEMENT

The current sanctioned post in non-teaching posts are far in excess of AICTE norm of 1:1.1 and hence cannot be used as the basis for fresh recruitment. The Board advised the institute to rationalise the post of non-teaching staff keeping in mind 1:1.1 ratio. It was accepted that NITTTR is a special kind of institute, hence 1:1.1 ratio is not fully applicable to this institute. However, the institute was advised to consult with other NITTTRs and prepare a consolidated non-teaching requirement institute-wise and submit co-jointly the requirements to the ministry for consideration and approval. In the meantime, the institute was advised to make a separate request to the ministry for allowing those essential/priority posts as an immediate necessity to get the permission to advertise and fill up such posts.
